**Where:** Bridge Base Online (BBO)

**Play only against pairs in your flight**

<u>Flight</u>	<u>Who is eligible</u>	<u>Conventions Allowed</u>
<b>Championship</b>	Open to all players	Open+ Chart
<b>Flight A</b>	Players with fewer than 6000 Master Points	Open Chart
<b>Flight B</b>	Players with fewer than 3000 Master Points	Basic+ Chart
<b>Flight C</b>	Non-Life Masters with fewer than 750 MPs	Basic+ Chart

All participants must have pre-qualified in a District NAP Qualifying Game at the club level and be paid-up members of ACBL in good standing.

Winners of District NAP Finals qualify for the NAP Finals held at the Spring 2026 NABC in St. Louis, MO:

- The top three pairs in the Championship Flight and Flight A play Wed/Thu February 25-26, 2026
- The top four pairs in Flights B and C play Sat/Sun March 7-8, 2026

ACBL provides subsidies to attend the NABC NAP Finals. First-place District winners in each Flight receive \$1,400/pair. Second-place pairs in each flight receive \$600/pair.
